This Contract entered into by and between:

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

  - iii. Qualifications of Personnel;
  - iv. Manpower and Work Schedule;

- v. General and Special Conditions of Contract; Supplemental or Bid Bulletins, if any;
- vi. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the UNIVERSITY'S bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the UNIVERSITY concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of **ONE MILLION FOUR HUNDRED SEVENTY-TWO THOUSAND THREE HUNDRED THREE PESOS AND FORTY-THREE CENTAVOS (PHP1,472,303.43)** or such other sums as may be ascertained, **TCO SECURITY AGENCY** agrees to the Delivery of Security Services in accordance with its Bid.

4. The **LEYTE NORMAL UNIVERSITY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

5. The duration of this Contract is from **August 1, 2021 to December 31, 2021.**
