

CONTRACT AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This **Contract** entered into by and between:

The **LEYTE NORMAL UNIVERSITY** located in Tacloban City, an institution of higher learning created by virtue of Republic Act 7910, represented by its University President, **DR. EVELYN B. AGUIRRE**, hereinafter referred to as the **UNIVERSITY**;

and

HEATHER PLUS HOME FURNISHINGS ENTERPRISES located at Brgy. Abucay, Tacloban City and a duly registered entity with the DTI and licensed to operate business by the City of Tacloban, represented herein by its Proprietor, **MR. HOMER S. UY** hereinafter referred to as the **CONTRACTOR**.

WITNESSETH

WHEREAS, the **CONTRACTOR** has offered to undertake for the **UNIVERSITY** the **SUPPLY AND DELIVERY OF VARIOUS FURNITURE AND FIXTURES**;

WHEREAS, the **UNIVERSITY** has allocated sufficient funds to cover the cost of the project in the estimated amount of **ONE MILLION FIVE HUNDRED NINETY-NINE THOUSAND FIFTY PESOS (P1,599,050.00)** only and the **CONTRACTOR** has accepted the same to be completed within **30 Calendar days** in accordance with the Contract;

WHEREAS, the **UNIVERSITY**, in accordance with the Bids and Awards Committee Resolution No. 112 F s. 2021 and by the authority of Dr. EVELYN B. AGUIRRE as University President to enter into contract with **HEATHER PLUS HOME FURNISHINGS ENTERPRISES**, has found such cost reasonable and advantageous to the government because of the extensive scope at a considerably low price;

NOW THEREFORE, the **UNIVERSITY** hereby awards this contract for the **PROCUREMENT OF VARIOUS FURNITURE AND FIXTURES** and both parties have agreed on the following:

3.0 OBLIGATION OF THE UNIVERSITY



3.2 The UNIVERSITY shall resort to charging of liquidated damages payable by the CONTRACTOR in case of unsatisfactory performance or violation of any provision of this Contract.

4.0 EFFECTIVITY OF THE CONTRACT

4.1 This Contract shall take effect upon receipt of the Notice to Proceed by the CONTRACTOR and shall remain in force and effect for one (1) month or until rescinded mutually by the parties.


