The **Leyte Normal University**, through the **National Expenditure Program**, Invites contractors registered with and classified by the Philippines Contractors Accreditation Board (PCAB) to apply for eligibility and if found eligible, to bid for the hereunder contract:

Contract Duration : **300 Calendar days**

Prospective bidders should possess a valid PCAB License applicable to the contract, have completed a similar contract with a value of at least 50% of the ABC, and have key personnel and equipment (listed in the Eligibility Form) available for the prosecution of the contract. The Prospective bidders should have owned the following equipment: 4 Ton-Terrain Telescopic Crane, 10 wheelers Dump Truck w/ 12 cu.m. capacity, 1 cu.m. Bucket Excavator, Pile Driver Vibro Hammer (owned/leased), 2-ton Dropside Truck w/ Crane and One Bagger Conc. Mixer. The BAC will use non-discretionary pass/fail criteria in the Eligibility Check/Screening as well as the Preliminary Examination of Bids. The BAC will conduct post-qualification of the lowest calculated bid.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluations of Bids, Post Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulations (IRR).
