Brief Description : **Scope of works involve: I. General Requirements, II. Site Development, III. Concrete Works, IV. Reinforcing Bars, V. Structural Steel Works for Foot Bridge, VI. Plumbing Works, VII. Fire Protection Works, VIII. Electrical Works, IX. CCTV, X. Painting Works, XI. Furniture and Fixtures, XII. Waterproofing at Roof Deck, XIII. Construction Safety and Health**

Approved Budget for the Contract (ABC) : **Php 37,214,831.50**

Contract Duration : **150 Calendar days**

Proponents/bidders should possess a valid PCAB License applicable to the contract, have completed a similar contract with a value of at least 50% of the ABC, and have key personnel and equipment (listed in the Eligibility Form) available for the prosecution of the contract. Bucket Capacity Excavator, 2-ton Dropside Truck w/ Crane, One Bagger Conc. Mixer and 50 KVA Generator Set.
